INTRODUCTION & BACKGROUND

Each county in the state of Iowa is required to complete a Community Health Assessment every five years. From this assessment, a 5-year Health Improvement Plan is completed. The assessment was postponed from 2020 and completed in 2022. Following is the report of the findings of the assessment and the improvement plans. This assessment enables public health officials to examine current health status indicators, identify key problems, as well as assets in the county and to determine and develop a Community Health Improvement Plan (HIP).

METHODS

Review of current data sources

1. Primary Research

A survey was created to elicit health and wellness information from those living in Union County and distributed across the county for those living in Union County to complete. Survey content and questions were solicited from the members of coalitions, boards, and elected officials.

The survey was conducted July-August 2022 and consisted of 11 multiple choice questions related to health and well-being with options to write in additional information. An additional five demographic questions were included.

Survey questions included rating the health of the county, identifying the most important factors for a healthy community, identifying the top three health problems in the county, identifying the three most risky behaviors and concerns, and selecting activities that would help families start or maintain a healthy lifestyle.

Survey questions also asked quality of health care delivery in Union County, rating of their own personal health, barriers to being healthy, utilization of health services and type of services received outside of the county and utilizing specific health care practices.

2. Secondary Research

We reviewed statistics and data from several sources, specifically focusing on the data included in the County Health Rankings and Roadmaps and the U.S. Census Bureau statistics.

Our data review also included review of previous Community Health Needs Assessments and improvement plans.

3. Community Presentations

Multiple strong boards and groups are currently in place within the county. To ensure the segments of the populations represented by these entities participated in the needs assessment process, surveys were taken to and distributed among these groups. Many partners participated including the two public school systems - Creston and East Union and the Union County Development Corporation.

In addition, survey presentations were conducted at a variety of community events including the county fair, the farmer's market, meal sites, and diverse festivals across the county.

Strengths and Limitations

The strengths of this assessment include the variety of places in which feedback was obtained. At multiple meetings of a variety of boards and groups, comments, suggestions for additions or subtractions, advice was solicited as the survey was created and edited for the final product.

Once the survey was completed, a similar system for distribution was utilized. Surveys were given to the boards and groups and disseminated throughout the county and a variety of outreach events. The response was significantly higher than in previous years, demonstrating a more accurate reflection of what is happening in the county.

A limitation of the Community Needs Assessment was encouraging the Latino/Hispanic population to complete the survey. It was often difficult to find this population and it was difficult to persuade them to complete the survey.

Key Participants

Union County Board of Health and Greater Regional Health were the main participants in this survey.

KEY FINDINGS

Union County is a county in Southwest/South Central Iowa. Geographically it serves as the middle point of a triangle between the metropolitan areas of Des Moines, Omaha and Kansas City. Union County is composed of six towns: Afton, Arispe, Cromwell, Lorimor, Thayer and county seat of Creston. The unincorporated city of Kent is also located in Union County. The population of the entire county was 12,018 according to the 2021 Census. Most (7,536) Union County residents live in Creston.

1. Demographics

1. Race: 96.2% white, 1.5% black or African American, 1.1% two or more races, .7% Asian, .5% American Indian/Alaskan native, 3.2% Hispanic or Latino
2. Age: Median age 40.6 years. 20.9% 65+ years; 22.4% <18 Years; 5.4% <5 years
3. Median annual income: \$50,375
4. 12.1% live below poverty line
5. 90.5% HS diploma

2. Survey Findings

A total of 294 surveys were completed. Nearly half of the respondents (46.42%) rated Union County as unhealthy, somewhat unhealthy or very unhealthy. The top three problems identified were substance abuse (66.55%), mental health or mental disorders (54.14%) and obesity and overweight at 50.34%.

The three most risky behaviors identified by those completing the survey include illegal drug use (77.89%), alcohol abuse (56.12%) and driving while impaired (37.07%). Lack of physical exercise was a close 4th and 36.73%.

Affordable wellness and fitness facilities, additional recreational paths, trails or sidewalks and the availability of fresh food and produces were identified as means to help families start or maintain a healthy lifestyle.

Most (87.03%) identified the quality of healthcare in Union County as “good” or “very good.” And most rated their own personal health in the “healthy” categories.

When identifying the variables that prevent the respondent from feeling healthier, three stood out among the rest in the numbers responding. These include financial concerns (37.99%), lack of motivation (54.12%) and not enough time (58.06%).

3. Health Outcomes Rankings

Overall, Union County ranks 91st out of 99 counties in Health Outcome Ranking. The county is 58 out of 99 for “Quality of Life,” which includes self-reported poor or fair health and poor physical health and mental health days. In addition, birthweight data is also included in this category.

Union County ranks the worst in the state in the “Length of Life” category. This reflects premature death rate (before 75 years of age). The leading causes of death under the age of 75 in the county include malignant neoplasms, diseases of the heart, accidents, and chronic lower respiratory disease.

Union County ranks 61st out of 99 in the Health Factors Category. Factored into this category are health behaviors, clinical care, social economic factors and physical environment. Each of these categories is also ranked with Health Behaviors ranking 74th out of 99; Clinical Care 10th out of 99; Social Economic Factors 90th out of 99 and physical environment 21st out of 99.


RECOMMENDATIONS

A Health Improvement Plan (HIP) has been completed.

The Health Improvement Plan will address 4 strategic Priorities.

1. Substance Abuse
2. Mental Health
3. Obesity and Overweight
4. Leading Causes of Death before age 75.

Community Health Assessment (CHA)

- Examination of health status indicators
- Gather data of the community's health status
- Identify key problems and assets in the county
- Used to develop a Community Health Improvement Plan (HIP)
 - Community determines priorities and goals to address
- Public Health Departments typically cycle CHA/CHIP every 5 years



- Social Economic Factors
 - Education, unemployment, poverty, crime, injury deaths
- Physical Environment
 - Water, air, housing, commute time

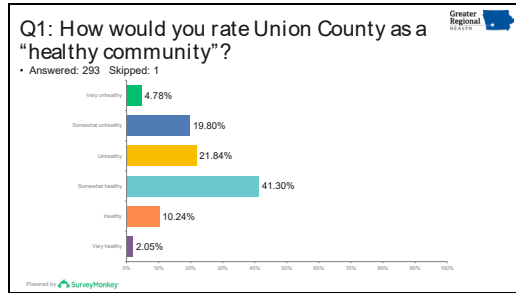

2022 Union County Community Health Assessment Survey

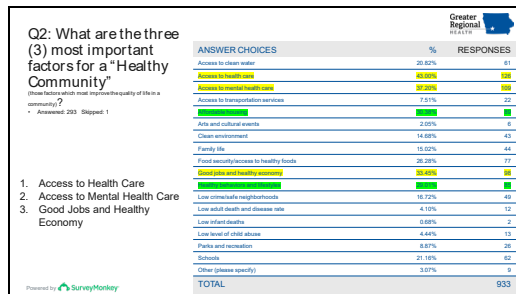
